

TERMS AND CONDITIONS

Reservations and Payments: A **NON-REFUNDABLE deposit** of \$300 per person is required at time of registration, along with a **signed reservation form**. Balance is due **60 days** prior to departure. Reservations may be cancelled if full payment is not received **60 days** prior to departure. Reservations received less than **60 days** prior to departure date must be paid in full.

Cancellation Policy: **All cancellations are subject to the pre-departure cancellation schedule below.** It must be in writing: mail, fax, or email. Noelette Tours reserves the right to cancel a tour. Penalties are not assessed when tours are cancelled by Noelette Tours. Noelette Tours is not responsible and does not assume responsibility for any additional costs relating to the issuance and/or cancellation of air tickets or other arrangements not made through Noelette Tours. Cancellations due to state travel advisories and/or state travel warnings, Acts of War, War, Terrorism, Acts of God, Natural Disaster or any other circumstance outside the control of Noelette Tours will not be eligible for refund. No refund or cancellation fees will be waived due to death or sickness.

45 days or less *NO REFUND*

Additionally, airline tickets and applicable taxes are non-refundable once issued, usually 6 weeks before departure. Group travel insurance will be automatically included in your invoice unless declined and initialed on the reservation form.

Passports and Visas: A valid passport, (at least 6 months valid from departure) is required for all. Noelette Tours assumes no liability for passport or visa procurements.

Baggage: Luggage is the passenger's responsibility and that of the airlines. For lost luggage claims, the passenger is responsible for notifying the airline directly.

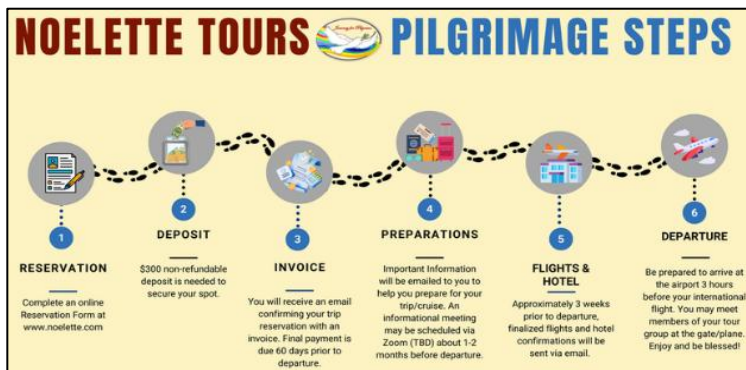
Responsibility and Liability:
